

Once the Applicant has read and understood the above documentation and wishes to continue with this application they should complete all relevant sections of this Application Form.

Once the application is fully completed and accepted, we notify the applicant and the application will be further assessed through an internal audit process.



# SUMMARY OF APPLICATION PROCESS

This process gathers essential details about the activity provider, the activity itself, and promotional content for marketing purposes. Below is a concise breakdown of each section and the required information:

## 1. Applicant Details

Collects the basic location details of the activity provider.

- Address: Unit/Street Number, Street Name
- City/Town Name
- Post Code/Zip Code
- Country

## 2. Activity Approval

Focuses on the activity seeking approval, including evidence of its quality.

- Activity Name
- Upload Evidence of the Activity
- Select the Type of Activity

### 3. Course Approval

# 3. Authorised Representative

Captures contact information of the applicant's representative.

- Title, First Name, and Surname
- Contact Number (with country code)
- Email Address

### 4. Promotional Information

Requires marketing materials and relevant details to promote the activity.

- Short Overview of the Activity (max 200 words)
- High-Resolution Logo
- Image and Video to Promote the Activity
- Date of the Activity
- Associated Fees
- Registration Link
- Contact Details for Queries
- Social Media Accounts Linked to the Activity and Organisation
