SUMMARY OF APPLICATION PROCESS

This application process involves multiple sections designed to gather comprehensive information about the applicant, their courses, and relevant promotional material. Below is a streamlined summary of each group and the key questions involved.

1. Applicant Details:

Collects the organisation's basic information and legal status.

- Legal Status & Ownership
- Quality Assurance System Used (e.g., ISO standards)
- Licenses/Certifications for Course Delivery (if applicable)

2. Authorised Representative:

Gathers contact details of the individual representing the applicant.

3. Course Approval

Focuses on the course seeking accreditation, including alignment with specific competencies.

- Course Name & Description
- Formal Recognition of the Course (if applicable)
- Supplementary Evidence: Demonstrates participant knowledge and skills acquired through the course
- Assessment Process (if applicable): Details on timing, methodology, and responsible party
- Select Specialisations: Areas like Trade Management, Digital Trade, Climate Smart Trade, etc.
- Choose Programs for Course Assessment

4. Promotional Information

Optional section for providing marketing materials and contact details for further inquiries.

- Short Course Overview (max 200 words)
- High-Resolution Logo
- Course Weblink
- Contact Information for Enquiries

This process ensures that applicants provide all necessary organisational, course, and promotional information to support the approval and marketing of their courses effectively on the EMTC and GTPA platforms.

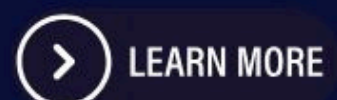
